**Recommended preparation advice:** Defrost the product for 2 / 3 hours at room temperature or in the refrigerator (0°C/+4°C) from one day to the next. Once defrosted keep it maximum 3 days in a refrigerated display cabinet. Remove the acetate tape before thawing. Keep at -18°C. Do not refreeze after thawing.
