Filling 26%: Sugar, vegetable oil (sunflower), defatted cocoa powder 2.1%, MILK whey powder, HAZELNUT paste, vegetable fat (palm), emulsifier (E322) and flavourings. Coating 14%: Sugar, vegetable fat (coconut and palm kernel), defatted cocoa powder 1.3%, MILK powder, flavourings, stabilizing (E492) and emulsifier (E322).
